- Setup/ Break Down: All Exhibitors must be set up and ready to sell by 11:00 am the day of the event. Exhibitors
  may begin setting up at 8:30 am the day of the Fair. Break down can start no sooner than 6:00pm on Sunday and must be
  completed by 7:30 PM. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces.
  \*Before leaving, be sure your area is clean and trash-free.
- 2. **Staffing**: Exhibitor tables/ booths must be manned at all times and intact until show closes at 8 p.m. The Venue is not responsible for merchandise or display materials.
- 3. Exhibitor Business Licence: All sellers must be registered by the City of Greenville to conduct business.
- 4. **Exhibitor Responsibility**: Exhibitor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. The Venue at Falls Park expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation. Each exhibitor is responsible for the conduct of his employees and/or representatives and activities must not detract from the image or welfare of the event.
- 5. Exhibitor Spaces: Exhibitor spaces will be assigned. Placement, flow and competition will be taken into consideration to provide the best experience for fair attendees.
